THE LOCATION

Arte Borgo Gallery, exhibition space set in the Borgo district in Rome, between the imposing Basilica of San Pietro and the mighty Castel Sant'Angelo. The Borgo district, rich in history, attracts thousands of people every day to discover a small neighborhood that retains its popular character.

THE EXHIBITION

The changes in an artistic journey are the reflection of the exhibition "Evoluzioni Contemporanee" addressed to the various forms of expression that each artist interprets during his / her journey.

Evolution as a transformation dictated in a more or less radical way by one's own existence, by one's own experience, making one perceive the fullness of a message adapting itself to the dynamic evolution of a modern observer.

"Evoluzioni Contemporanee" offers the opportunity to exhibit, in the space of the Galleria Arte Borgo, works of carefully selected artists who can freely express their creativity through their different languages.

Art. 1- Selection and participation

Selection and participation are available for artists of any nationality and without any age limit who should send via email a brief biography and three photos which represent the own artwork (unless the artist has a personal website).

Those who have already worked with the Association can skip this passage and may only show the artwork to be exposed.

The selection will occur <u>in parallel with</u> the outlook of the received material.

The <u>selected artists will pay an application fee of € 120,00</u> (one hundred and twenty euro) <u>per two</u> <u>artworks</u>, that is supposed to cover all the expenses as written in Art.6. The fee has to be paid within 5 days after the communication of the occurred selection.

Art. 2 – Technical specifications

Painting – Sculpture – Photography – Installation: there are no limits regarding style, technique, materials nor supports.

The allowed maximum dimensions should not be more than 100 cm of base. Possible different dimensions have to be agreed with the curator.

Art. 3 – Time limits and procedures of participation

The artists should adhere within and not later than the midnight of **November 3th**, **2018** sending an email with photos of some works and the completed application form at info@arteborgo.it

Art. 4 – Transfers and delivery of the artworks

The works can be sent with your own courier at Arte Borgo Gallery in Borgo Vittorio 25, Rome and the **delivery must be mandatory on November 7**th.

Art. 5 – Responsibilities

Despite guaranteeing the total care and custody of the exposed artworks, the event managers, Arte Borgo Gallery, decline any responsibility in case of possible theft, fires or any kind of damages towards the artworks and/or people which may occur during the entire exhibition period and during the transfer of the artworks carried out by the couriers.

Each selected artist allows the treatment of personal data transmitted in accordance with the law 675/96.

The application to the exhibition implies the knowledge and total approval of the present regulation.

Art. 6 – Participation fee

Participation fee, as indicated in the article 1st, it is mandatory for the selected artists and it guarantees the following services:

- Secretary
- Installation and dis-installation of the exhibition by specialized staff
- Security provided by professional staff
- Relationships with involved public and private institutions
- Critic's attendance on the day of vernissage
- Graphic planning and study of the event image by graphic designer & professional web master
- Graphic and typographic cure of the advertising material (invitations, banner)
- Graphic design and brochure print with the names of each artist. Each artist will receive a free copy.
- Videos and photos of the event visible on the network
- Event advertising & press office
- Welcoming vernissage
